I notice you have a blog on an individual who has operated in this country now for about 40-50 years under the false name "J.P. Kennedy". Should you be a real journalist I'm sure you would question the name seeing that this person claims to be from Hungary, the name is obviously Irish and also identical to Senator J.P. Kennedy.
